## Coaches Code of Conduct

The mission of the Boys & girls Clubs of the Rogue Valley includes providing a safe, positive and fun place for all kids. In order to provide such programs and activities, we need the support of the parents/guardians, volunteers and youth. This support includes agreeing to and abiding by a Code of Conduct that fosters positive, fun and safe environments.

It is important for all Coaches and Volunteers to understand that the Club and its activities are for the benefit of children and that all volunteers are required to conduct themselves in a manner consistent with creating a positive experience for children.

As a Coach or Volunteer, you are an important and impactful role model in a child's life. Your words and your actions will have an impact on the well-being of the children in your charge. Coaching is a privilege and with it comes responsibility. Coaches set the tone for their teams and are responsible for the conduct of their players, parents, other coaches and/or volunteers.

All children are influenced by leadership and authority and as their coach; I understand that I am a role model.

I agree to the following:

- I will place the emotional and physical well-being of my players ahead of any personal desire or pressure to win.
- I will not engage in any kind of unsportsmanlike conduct with any official, opposing coach, player, parent or spectator such as: arguing, refusing to shake hands, excessive yelling or belittling or using profane language or gestures.
- I will treat Club representatives, officials and opposing coaches with respect and will not engage in open arguments or confrontations.
- I will treat players fairly and will work towards improving a player's individual skills set and I will adhere to the player participation rules set forth for my sport by the Club.
- I will do my very best to provide a safe and encouraging playing situation for my team members.
- I will teach my players to treat other players, coaches and officials with respect regardless of age, race, creed, color, gender or ability.
- I will do my best to organize practices that are safe, fun and challenging for all players.
- I will lead by example in demonstrating fair play and sportsmanship to all players.
- I will be knowledgeable in the practice techniques and rules of the sport I coach. I will teach players to play by the rules and to resolve conflicts without resorting to hostility.
- I promise to review and practice the basic first aid principles needed to handle injuries of my players.
- I will use coaching techniques appropriate for the skills that I teach and remember that one of my most important achievements will be to teach my players to love the sport.
- I will remember that I am a youth sports coach and that all games are for children and not adults.

I understand that any violations may be submitted to the Athletic Director. Any grievances of the Athletic Director's decision may be submitted to the Club's Executive Director. Action may include temporary or permanent expulsion for all Club Programs.

I have fully read and fully agree to abide by this Coaches Code of Conduct. I will help my fellow coaches uphold this Code as well.
